

## THE BABCOCK COLLEAGUE SHARE PLAN INTERNATIONAL ("BCSPI") PHANTOM FREE SHARE AWARD TAX SUMMARY - CYPRUS

## 1. Will I be taxed when I am granted a Phantom Free Share Award?

No, you will not have to pay income tax or social security contributions when you are granted a Phantom Free Share Award.

## 2. Will I be taxed when the Phantom Free Share Award vests?

Yes, you will need to pay income tax, social insurance contributions and GHS contributions on the cash amount paid to you when your Phantom Free Share Award vests. Income tax rates are up to 35%, social insurance contributions apply at 8.8% and GHS contributions apply at 2.65%.

Your employer will withhold the income tax, social insurance contributions and GHS contributions due.

## 3. What do I need to do?

You will need to report the cash you receive on the vesting of a Phantom Free Share Award in your annual tax return.

This tax summary applies to any Phantom Free Share Award you may be granted under the Babcock Colleague Share Plan - International. We have assumed that you are tax resident in Cyprus and have been at all times from the grant of a Phantom Free Share Award to the vesting of a Phantom Free Share Award.
